- Rebates will be issued as a \$100.00 check from the City of Lincoln to the current City of Lincoln utility customer with an account in their name at the service address where the fixture is installed.
- Please allow up to 90 days for your completed application to be processed.
- Rebates are subject to program funding availability.
- City does not warrant, endorse, or assume liability for the quality, performance or safety of any product or services performed by any retail outlet, contractor, or employees or agents of same, related to any purchase under this program.
- Installations may be subject to inspection and verification. Customer agrees to allow the City of Lincoln to inspect the fixture at the installation address by appointment with prior notification.
- City reserves the right, at its sole and absolute discretion and at any time, to change any or all of the Terms and Conditions for the rebate program or to cancel the rebate program without prior notice.
- Incomplete applications will not be processed.
- Please do not mail your application with your utility payment.
- The maximum rebate per washer is \$100.00 or the purchase price of the washer, whichever is less.
- Repayment of rebate will be required if any Terms and Conditions are found to have been breached.
- Applicant is not eligible for the rebate if they purchase a clothes washer for a new home/apartment or new construction/development.
- Applicant is not eligible for a clothes washer rebate if they received a previous clothes washer rebate from the City.
- Incomplete or Illegible applications will be denied.
