## **RESOLUTION NO. 2024-03**

RESOLUTION OF THE BOARD OF DIRECTORS APPROVING OF THE LINCOLN-SMD 1 WASTEWATER AUTHORITY (LISWA)
TO JOIN THE CALIFORNIA SANITATION RISK MANAGEMENT AUTHORITY (CSRMA) AND PARTICIPATE IN THEIR PRIMARY INSURANCE PROGRAM FOR GENERAL LIABILITY, AUTOMOBILE LIABILITY, EMPLOYMENT PRACTICES LIABILITY, PUBLIC ENTITY ERRORS AND OMISSIONS LIABILITY, COMMERCIAL CRIME AND AUTO PHYSICAL DAMAGE COVERAGE, CSRMA'S PROPERTY INSURANCE PROGRAM AND APPOINTING LISWA'S GENERAL MANAGER AS PRIMARY REPRESENTATIVE AND THE GENERAL MANAGER'S DESIGNEE AS ALTERNATE REPRESENTATIVE TO THE CSRMA BOARD OF DIRECTORS

**WHEREAS**, the Lincoln-SMD 1 Wastewater Authority ("LiSWA" or "Authority") is a joint powers agency organized and operating pursuant to the provisions of the Constitution and the laws of the State of California ("State") by and between the City of Lincoln and the County of Placer; and

WHEREAS, the California Sanitation Risk Management Authority ("CSRMA") is a member governed, staff administered, JPA formed in 1986 to provide members with cost effective self insured risk sharing/pooling and group purchasing coverage for third-party liability specific to wastewater operations through their Primary Insurance Program for general liability, automobile liability, employment practices liability, public entity errors and omissions liability, commercial crime and auto physical damage coverage, and CSRMA's Property Insurance Program; and

WHEREAS, the Authority deems joining CSRMA for the purpose of jointly funding and/or establishing primary coverage, excess coverage, other coverage, loss control, and loss prevention programs to be in the best interest of LiSWA.

# NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE LINCOLN-SMD 1 WASTEWATER AUTHORITY DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

**Section 1.** All of the recitals herein contained are true and correct and the Board of Directors so finds.

**Section 2.** The Board of Directors hereby approves and intends to participate in CSRMA's Primary Insurance Program for general liability, automobile liability, employment practices liability, public entity errors and omissions liability, commercial crime and auto physical damage coverage, their Property Insurance Program and appointing LiSWA's General Manager as Primary Representative and the General Manager's designee as Alternate Representative to the CSRMA Board of Directors; and

- (A) Agrees to pay CSRMA an estimated annual amount of \$260,000 for initial membership fee, initial premium, and Underwriting Fee
- (B) Agrees to participate in the Primary Insurance Program for at least one (1) full program year and to give two (2) months prior notice if intending to withdraw.

(C) Agrees to participate in the Property Insurance Program for at least one (1) full program year and to give two (2) months prior notice if intending to withdraw.

**Section 3.** The officers of the Authority are hereby authorized and directed to take such other and further actions as are necessary or as may be appropriate to effectuate the directions and approvals set forth in this Resolution, including, without limitation, the Chair of the LiSWA Board being hereby authorized to execute, on behalf of the Authority, the Agreement, the Liability Program Participation Agreement, and the Board of Directors Status Form for CSRMA, and give notice, or cause notice to be given, to CSRMA that the Authority intends to participate in CSRMA.

**Section 4.** This resolution shall take effect from and after its date of adoption.
