

Esplanade at Turkey Creek has annexed to CFD 2018-1 (Maintenance Services), Tax Zone 13, to fund the maintenance of open space, landscaping, the neighborhood park, traffic signals, streetlighting on Ferrari Ranch Road, McBean Park Drive and Oak Tree Lane, and drainage improvements along Ferrari Ranch Road and Oak Tree Lane. Esplanade at Turkey Creek has also annexed to CFD 2018-2 (Public Services), Tax Zone 6, to mitigate the impact to Lincoln's public services. The Home Owners' Association will maintain the private streets, frontage landscaping, and other infrastructure within the subdivision.
