This public hearing will consider an appeal of the Planning Commission's approval of the Specific Development Plan and Development Permit (Design Review) for Deer Crossing, a 23,700 square-foot retail center within the Sun City Lincoln Hills Community, Twelve Bridges Plan Area B, Assessor's Parcel Number's 338-010-057. The appeal, which was timely filed by William Rath of Lincoln Christian Life Center, will be heard pursuant to the City of Lincoln Municipal Code Chapter 18.94 (Appeals).

The Planning Commission conducted a public hearing on the project on September 21, 2022 and approved the Specific Development Plan and Development Permit (Design Review) for Deer Crossing with a 4-2 vote under Planning Commission Resolution No. 2022-21. An appeal of the decision was timely filed with the City on September 30, 2022 during the 10-day appeal period.

Pursuant to the requirements of the California Environmental Quality Act (CEQA) and the City's Environmental Guidelines, the City has determined that the project continues to be exempt from environmental review pursuant to CEQA Guidelines Section 15162. This site was analyzed for commercial development within the previously adopted Subsequent Environmental Impact Report for the Revised Twelve Bridges Specific Plan (State Clearing House #97022074). Therefore, no further environmental analysis is required.

Administrative remedies must be exhausted prior to action being initiated in a court of law. If you challenge these remedies in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the Community Development Department at, or prior to, the public hearing.
