ORDINANCE 1057B

AN ORDINANCE OF THE CITY OF LINCOLN AMENDING CHAPTER 10.56.010 TO THE LINCOLN MUNICIPAL CODE ESTABLISHING SPEED LIMITS FOR VARIOUS STREET SEGMENTS THORUGHOUT THE CITY

Recitals

WHEREAS, Cities and Counties in California are required to follow the California Vehicle Code (CVC) Sections 22357 and 22358 to establish speed limits within their jurisdictions; and

WHEREAS, CVC Sections 22357 and 22358 grant the City authority to determine and declare speed limits, other than those established as prima facie by CVC Section 22352, by ordinance; and

WHEREAS, Engineering and Traffic Surveys were conducted for various roadway segments throughout the City; and

WHEREAS, Engineering judgement deemed it necessary to reduce the proposed speed limit on several road sections by 5 mph from the 85th percentile speed. The reason for doing so was to better align the posted speed limit within the 10-mph Pace. The 10-mph Pace is the 10-mph increment range which contains the largest number of recorded vehicles. Speed limits should normally be set to fall within the 10-mph Pace; and

WHEREAS, The road segments that were reduced to fall within the 10-mph Pace are as follows: Bella Breeze between East Joiner Parkway and Del Webb Boulevard, Colonnade Drive between Bella Breeze Drive and Twelve Bridges Drive, Dresden Drive between Bella Breeze Drive, East Joiner Parkway between Twelve Bridges Drive and Fieldstone Drive, East Joiner Parkway between Fieldstone Drive and the Southern City Limits, Eastridge Drive between Bradborne Drive and Omega Drive, and Galewind Drive between Dresden Drive and Colonnade Drive; and

WHEREAS, The speed limit on East Joiner Parkway between Fieldstone Drive and the Southern City Limits and the speed limit on Eastridge Drive between Bradborne Drive and Omega Drive were both reduced from the 85th percentile speed by 5 mph but did not result in a change from the existing posted speed limit; and

WHEREAS, The speed limit on East Joiner Parkway between Twelve Bridges Drive and Fieldstone Drive was reduced from the 85th percentile speed by 5 mph but still resulted in an increase in the declared speed limit from 35 mph to 40 mph; and

WHEREAS, The road segments on Bella Breeze, Colonnade Drive, Dresden Drive, and Galewind Drive have not previously had speed surveys conducted and thus do not currently have a posted speed limit; and

WHEREAS, The 85th percentile speed for Brentford Circle between Caledon Circle/Chelsea Lane and Caledon Circle fell within the 10-mph Pace and therefore did not require the 5 mph reduction but still resulted in an speed limit reduction from the existing speed limit of 35 mph down to a proposed speed limit of 30 mph; and

WHEREAS, The City Council does hereby approve the prima facie speed limits on certain City streets; and

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of Lincoln does hereby ordain as follows:

<u>Section 1.</u> Chapter 10.56.010 is hereby amended to the Lincoln Municipal Code to read as follows:

<u>10.56.010 Speed Limit Establishment</u>. As described by Sections 22357 and 22358 of the California Vehicle Code, the City Council hereby determines that based upon engineering and traffic surveys, the speed limits set forth in this section facilitate the orderly movement of traffic, and are reasonable, safe, except when passing a school building or school grounds, or senior center. The City Council hereby declares the following speed limits:
