Guest List – A guest list must be submitted to the pool front desk on the day of the party. _____ (initials)

Party Times – Party time is limited to the hours of Recreation Swim, 2 – 5pm. Access to your reserved party area with party host is limited to the one hour as specified in the Birthday Party Contract. _____ (initials)

Chaperones – It is required that there be at least 1 adult in attendance for every 10 children over the age of 8 and 1 adult in attendance for every 5 children under the age of 8. _____ (initials)

Alcohol – Is prohibited _____ (initials)

Contract Changes – All changes from the original agreement must be approved by the Pool Manager no less than 7 days in advance of the party date. _____ (initials)

Cancellations/Refunds – All requests must be submitted in writing to the Pool Manager. Requests received 10 business days prior to party date will receive a full refund minus a \$25 processing fee.
